Please be advised that [REDACTED] has purchased Patriot International® certificate number PATII81837287 effective 10-Mar-2018 to 21-Mar-2018. The policy is administered by International Medical Group®, Inc., and underwritten by Sirius International Insurance Corporation (publ) located at 113 96 Stockholm, Sweden. Sirius has an "A" (Excellent) rating from A.M. Best.

Medical coverage is provided while traveling worldwide outside of the insured person's Home Country including Italy, per policy provisions. Coverage includes the Schengen states per the policy provisions. Emergency evacuation (also known as Repatriation) is provided up to a maximum benefit of 500,000.00 USD and Return of Mortal Remains benefits up to a maximum of 50,000.00 USD are included when coordinated by IMG. 
